CONSTRUCTION OF CHATO BUS TERMINAL

1. The Government of Tanzania has set aside funds for the operation of the **Chato District Council** during the financial year 2018/2019. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the **Construction of Chato Bus Terminal-Phase 1**.
2. The Chato District Council invites sealed Tenders from eligible contractors registered or capable of being registered in Class III and above for Building Construction for carrying out the **Construction of Chato Bus Terminal Phase 1**.

The works consist of:

- Construction of Ground floors (partly block 1, 3, and 4 as per drawings), which comprises of Retail shops, Booking offices, Min Supermarket, Restaurant and General stores.
3. Tendering will be conducted through National Competitive Tendering (NCT). Tendering procedures specified in the Procurement (Goods, Works, Non Consultancy service and Disposal of Public Assets by Tender) Regulations, 2013 GN 446 with its amended Act and Regulations of 2016.
 4. Interested eligible Bidders may obtain further information from and inspect the Tendering Documents at the office of the **Secretary of the Council Tender Board, P. O. Box 116, Chato - Geita. From 7:30 am to 15:30 hours on Monday to Friday inclusive except on weekends and public holidays.**
 5. **Qualification requirements include:** Legal status of the Bidder, proposed major equipment's for carrying out the work, Qualification and experience of the key personnel, Experience in similar work, Financial status of the Bidder, Certificate of

registration with CRB in Class III and above for Building Construction, proposed sub-contractors and firms involved (if any). Annual subscription fee of 2017 or 2018, Extract of Registration Company Directors, Valid Business License and Tax payer Identification Number.

6. A complete set of Tendering Documents in English, in hard copy and additional sets may be purchased by interested Bidders upon payment of non-refundable fee of Tanzania shillings Two Hundred Thousand only (**TZS. 200,0 00.00**). Payment should be paid through NMB Bank after receiving payer identification number from the Chato District Treasurer Office.
7. All Tenders must be accompanied by a Tender securing declaration in an acceptable form provided in the Tendering documents.
8. All Tenders in one original plus two (2) copies must be properly filled in, and enclosed in plain envelopes marked: **Tender NO. LGA/039/2018/2019/CDG/W/01 PHASE 1 for Construction of Chato Bus Terminal**
9. The deadline for submission of tender document is at or before **11:00 am on 27/09/2018**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening Ceremony.
10. Late tenders, portion of tenders, electronic tenders, and tenders not received, tenders not opened at the tenders opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
